Terms and Conditions

The Customer agrees to and accepts these terms and conditions as only the terms and conditions applying to the sale of the products (“Products”) purchased from AngioDynamics, Inc. (“AngioDynamics”). No additional terms, conditions, consents, waivers, alterations, or modifications shall be binding unless in writing and signed by the parties. Customer’s additional or different terms and conditions, whether stated in a purchase order or other document issued by Customer, are specifically rejected and shall not apply to the transactions contemplated hereby. AngioDynamics shall not be deemed to have waived these terms and conditions of sale if it fails to object to provisions appearing on, incorporated by, referenced in or attached to Customer’s order form.

Payment Terms

Terms of sale are Net 30 Days. In the event of late payment, AngioDynamics may access a service charge of the lower of 1.5% per month or the highest rate permitted by law on the unpaid balance.

Method of Shipping

F.O.B. Factory. Prepaid and added/invoiced according to Payment terms.

Federal law (U.S.A.) restricts these devices to sale to or on the order of a physician.

Specification Changes

AngioDynamics is committed to improving our products. As such, the Products or equipment supplied may not agree in all details with the description and specification shown in the catalogue or price list. Specifications are subject to change without prior notification. We reserve the right to discontinue any product without prior notification.

Returned Goods

The following information is required with your return:

All items must be returned in unopened boxes and are subject to a 20% restocking charge. AngioDynamics will accept returned goods within 30 days of purchase. Merchandise that has been opened, damaged, or tampered with is not returnable. Products manufactured as special or custom products are not returnable.

Security Interest

Customer hereby grants to AngioDynamics a purchase money security interest in the Products until all payments have been made. Customer shall sign any financing statements or other documents necessary to perfect AngioDynamics’ security interests in the Products. Where permitted by applicable law, Customer’s signature on this Agreement gives AngioDynamics the right to sign on Customer’s behalf and file any financing statement or other documents to perfect AngioDynamics’ security interest in the Product.

Product Warranty

Unless set forth in a specific Warranty Statement:

AngioDynamics warrants to the original purchaser only that the Products (a) subject to specification changes above, substantially conform to the specifications set forth herein or, if none are set forth, to AngioDynamics' published specifications and (b) is free from defects in material or workmanship. Descriptions or specifications in AngioDynamics' literature are meant solely to describe the applicable product at the time of manufacture and do not constitute any warranty of any type, express or implied, including without limitation a warranty of merchantability. The duration of this warranty is one year from the date of delivery. If the Customer discovers within this period a failure of the Product to conform to specifications or a material defect in material or workmanship, the Customer must promptly notify AngioDynamics as set forth herein. In no event shall such notification be received by AngioDynamics later than thirteen months from the date of delivery and no action for breach of warranty may be commenced after fifteen months following delivery of the Products in issue.

It is Customer's responsibility to check the Product upon receipt and before putting into process. This warranty does not cover damage caused by use of the Product for any purpose for which it was not designed, damage caused by unauthorized modification, damage during shipping or storage, or any other abuse or misuse by Customer.

THE FOREGOING WARRANTIES ARE EXCLUSIVE IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, WITH RESPECT TO THE GOODS SOLD, INCLUDING BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

IN NO CASE SHALL ANGIODYNAMICS BE LIABLE IN RESPECT OF THE GOODS OR ANY USE THEREOF, FOR ANY SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES BASED UPON BREACH OF CONTRACT, NEGLIGENCE, STRICT LIABILITY, OR ANY OTHER LEGAL THEORY. SUCH DAMAGES INCLUDE, BUT ARE NOT LIMITED TO, LOSS OF PROFITS, LOSS OF SAVING OR REVENUE, LOSS OF USE OF ANY MACHINERY OR ANY ASSOCIATED MACHINERY, COST OF CAPITAL, COST OF ANY SUBSTITUTE EQUIPMENT, FACILITIES OR SERVICES, DOWN-TIME, THE CLAIMS OF THIRD PARTIES (INCLUDING CUSTOMERS) AND INJURY TO PROPERTY. IN NO EVENT SHALL THE AMOUNT OF A CLAIM EXCEED THE PURCHASE PRICE PAID UNDER THE PARTICULAR PURCHASE ORDER. THIS LIMITATION DOES NOT APPLY TO CLAIMS FOR PERSONAL INJURY. THESE TERMS MAY NOT BE ALTERED, AMENDED, REPLACED, SUBSTITUTED OR RESCINDED BY ANY EMPLOYEE, AGENT, INDEPENDENT CONTRACTOR OR CONSULTANT OF ANGIODYNAMICS. ANY SUCH ALTERATION, AMENDMENT, REPLACEMENT, SUBSTITUTION OR RESCISSION SHALL NOT BE BINDING UPON ANGIODYNAMICS OR ITS AFFILIATES.

The sole obligation of AngioDynamics under this warranty shall be to provide Customer free of charge with replacements for parts of Products, or in the sole discretion of AngioDynamics, complete Products, which are found to be defective within the warranty period with the same delivery terms as the original Products.

Indemnification

AngioDynamics shall defend or settle any claim against Customer that a Product provided in this Agreement infringes a valid claim under a United States patent provided that the Customer (i) provides AngioDynamics prompt written notice of the claim, (ii) grants AngioDynamics full and complete information and assistance necessary for AngioDynamics to defend, settle, or avoid the claim, and (iii) gives AngioDynamics sole control of the defense or settlement of the claim. The provisions of this section shall not apply in the event of any sale or other transfer of the Product by the Customer. In the event the Products are found or believed by AngioDynamics to infringe such claim, AngioDynamics may, at its option, (i) procure the right for the Customer to use the Product, (ii) replace or modify the Product to avoid infringement, or (iii) refund to the Customer a portion of the Product purchase price upon the return of the original Product. AngioDynamics shall have no obligation for any claim of infringement arising from AngioDynamics' compliance with the Customer's designs, specifications, or instructions; AngioDynamics' use of technical information or technology supplied by the Customer; modifications to the Product by the Customer or its agents; use of the Product other than in accordance with the Product Specifications or applicable written Product instructions; use of the Product with products not manufactured by AngioDynamics; use of the Products if infringement would have been avoided by the use of a current unaltered release of the Products; or use of the Products after AngioDynamics has offered the Customer one of the options described in this section. The terms in this section state AngioDynamics' entire obligation and liability for claims of infringement, and the Customer's sole remedy in the event of a claim of infringement.

Compliance with Laws

Each party shall comply with all laws, rules and regulations applicable to the party in connection with the performance of its obligations in connection with the transactions contemplated hereby, including, but not limited to, those relating to affirmative action, fair employment practices, FDA, Medicare fraud and abuse, and the Health Insurance portability and Accountability Act of 1996 ("HIPAA"). Health care providers are reminded that if the purchase includes a discount or loan, they must fully and accurately report such discount or loan on cost reports or other applicable claims for payment submitted under any federal or state health care program, including but not limited to Medicare and Medicaid, as required by federal law (see 42 CFR 1001.620 [h]).

If any term or provision of these terms and conditions of sale shall, to any extent, be held by a court of competent jurisdiction to be invalid or unenforceable, the remaining terms or the application of such term or provision to persons or circumstances other than those as to which it has been held invalid or unenforceable, shall not be affected thereby and these terms and conditions of sale shall be deemed severable and shall otherwise be enforced to the full extent permitted by law.

- 1. License Grant.** Subject to Customer's compliance with the terms and conditions set forth above, AngioDynamics grants to Customer ("Licensee") a non-exclusive, non-transferable, non-sublicensable license to use the computer software package ("Licensed Software"), in its object code form, solely in connection with the operation of the capital equipment set forth in the applicable sales agreement or quote. The license shall continue for as long as Licensee continues to own the product, except that AngioDynamics may terminate the license in the event of any default by Licensee. Licensee shall return the Licensed Software and any authorized copies thereof to AngioDynamics immediately upon expiration or termination of this license.
- 2. License Restrictions.** Except in connection with Licensee's express rights described in these terms and conditions, Licensee may not (a) decompile, reverse engineer, disassemble or otherwise attempt to derive the source code or reduce the Licensed Software to a human readable form, or permit any other party to do so, or create derivative works of or from the Licensed Software or (b) modify, adapt, translate, rent, lease, sublicense, loan, resell transfer, display, distribute, network or create derivative works based upon the Licensed Software or any part thereof.
- 3. Title.** AngioDynamics retains all right, title, and interest in and to the Licensed Software, any and all services performed in connection therewith, and any other content, products, documentation, software, materials, or other technology related to the Licensed Software including, but not limited to, any and all modifications, enhancements, updates, and configurations, whether written, printed, electronic, or in source code or any other format, and any patent, copyright, trade secret, trademark, service mark, or other intellectual property rights in any of the foregoing (the "AngioDynamics Property"). AngioDynamics grants only those rights and licenses expressly provided for herein and does not thereby transfer any title or ownership interest to the AngioDynamics Property or any modifications, enhancements, or derivative works thereof. Licensee shall not interfere with or otherwise challenge AngioDynamics' rights in the AngioDynamics Property, or remove or alter, or cause or allow to be removed or altered, any notice, symbol, or legend of any trademark, copyright notice, or other proprietary rights appearing in or on any of the AngioDynamics Property. Licensee hereby assigns to AngioDynamics all rights Licensee may have in any and all suggestions, concepts, improvements, or other enhancements communicated by Licensee to AngioDynamics that are incorporated into the Licensed Software. Licensee shall keep the Licensed Software free and clear from any claims, liens, or encumbrances. Customer may make one back-up copy of the licensed Software for internal purposes.
- 4. Limited Warranty.** AngioDynamics warrants that for a period of ninety (90) days from the date of shipment from AngioDynamics: (i) the media on which the Licensed Software is furnished will be free of defects in materials and workmanship under normal use; and (ii) the Licensed Software substantially conforms to its published specifications. Except for the foregoing, the Licensed Software is provided AS IS. This limited warranty extends only to Licensee as the original licensee. Licensee's exclusive remedy and the entire liability of AngioDynamics and its suppliers under this limited warranty will be, at AngioDynamics' or its service center's option, repair, replacement, or refund of the Licensed Software. In no event does AngioDynamics warrant that the Licensed Software is error free or that Licensee will be able to operate the Licensed Software without problems or interruptions.

This warranty does not apply if the Licensed Software (a) has been altered, except by AngioDynamics, (b) has not been installed, operated, repaired, or maintained in accordance with instructions supplied by AngioDynamics, (c) has been subjected to abnormal physical or electrical stress, misuse, negligence, or accident, or (d) is used in ultra hazardous activities.

The Software is licensed to Licensee on the basis that (a) Licensee shall maintain the configuration of the products as they were originally designed and manufactured and (b) the product includes only those subsystems and components certified by AngioDynamics. 5. Assignment or Sale. Licensee will not assign, subcontract, sell, or otherwise transfer the Licensed Software or its rights or obligations under this Agreement without the prior written consent of AngioDynamics.
6. New Versions. The Licensed Software may be updated periodically to ensure its compatibility with AngioDynamics' products. This License provides the same rights to use the updated Licensed Software as provided for herein. Licensee must install all updates as directed by AngioDynamics, promptly after receipt, or allow, at AngioDynamics' discretion, AngioDynamics to install such updates.
7. Open Source Prohibition. Licensee's rights under this License are conditioned upon Licensee not performing any actions in a manner that would require any Licensed Software and/or any derivative work thereof, to be licensed under Open License Terms (defined below) such as: (a) combining such Licensed Software, the product or a derivative work thereof with Open Source Software (defined below), by means of incorporation of linking or otherwise; (b) distributing such Licensed Software, the product or a derivative work thereof with Open Source Software; or (c) using Open Source Software to create a derivative work of the product or of such Licensed Software, insofar as these actions would require such Licensed Software, the product or a derivative work thereof to be licensed under Open License Terms. "Open Source Software" means any software that is licensed under Open License Terms, "Open License Terms" means terms in any license agreement or grant that require as a condition of use, modification and/or distribution of a work that: (i) source code shall be made available; (ii) permission shall be granted for creating derivative works; or (iii) a royalty-free license is granted to any party under any intellectual property rights regarding that work and/or any other work that contains, is combined with, requires or is based on that work.
8. Third Party Software. Any third party software included with the product shall be subject to the terms of the third party software licensor's end user license agreement ("EULA"). Notwithstanding the above, AngioDynamics' warranty and service obligations set forth in these terms and conditions shall not be impacted, regardless of specific third party software that is utilized in connection with the product.
9. Limitation of Liability.
THE WARRANTIES SET FORTH IN ANGIODYNAMICS' WARRANTY DOCUMENT WITH RESPECT TO A PRODUCT (INCLUDING THE SOFTWARE PROVIDED WITH THE PRODUCT) ARE THE ONLY WARRANTIES MADE BY ANGIODYNAMICS IN CONNECTION WITH THE PRODUCT AND THE SOFTWARE AND THE TRANSACTIONS CONTEMPLATED BY THE AGREEMENT ATTACHED TO THIS LICENSE AGREEMENT, AND ARE EXPRESSLY IN LIEU OF ANY OTHER WARRANTIES, EXPRESSED OR IMPLIED INCLUDING, WITHOUT LIMITATION, ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
