

## 2022 REIMBURSEMENT CODING GUIDE

The RadiaDyne IsoLoc Prostate Immobilizer System is used to immobilize the prostate in patients undergoing radiation therapy. The device is intended to be used during all phases of radiation therapy, including treatment planning, image verification, and radiotherapy delivery. The use of the device must be ordered by the physician and documented in the patient record. Providers are responsible for selecting the most appropriate code for the device based upon medical necessity and should check with local payors for additional coding guidance or policies.

**Indications For Use:** The RadiaDyne IsoLoc Endorectal Balloon is a single-use disposable, inflatable, non-powered positioning device intended for use in the temporary positioning of the rectal wall and adjacent structure in the male human anatomies. The purpose of the device is to stabilize the prostate during Computed Tomography (CT) exam and X-ray, when these imaging techniques are used for Radiation Therapy (RT) planning. The placement of the balloon requires a Physician, or a Physician directed healthcare professional, and is performed as a separate procedure apart from the standard CT exam and RT treatment.

**Contraindications:** • Hemorrhoids • Peri-rectal / Peri-anal abscess • Anal Fissure, Anal Canal Stricture • Prior low anterior resection • Rectal Fistula, Rectal Fissure, Rectal Ulcer • Diverticulitis • Surgery of the prostate, rectum, or surrounding area within the last eight • weeks • Radiation of the rectum or surrounding area within the last eight weeks • Any standard exclusionary criteria recognized for endo-rectal / intra-rectal devices
